NEW BUSINESS:

1. Approve the Fourth Amendment for Ranger Dispatch Service Agreement with the County of Orange

Director Edwards reported to the Board that West-Comm has been providing Park Ranger dispatch services to the County for 15 years, since 2007. The current services agreement is set to expire this year on December 31, 2022. Initial contractual charges were based on the number of Ranger calls per month, with an annual increase based on CPI.

Last contract renewal in 2017, included a new billing methodology to recover the cost of Dispatch services along with one-time fees for recent dispatch enhancements. West-Comm currently charges the fully loaded annual salary and benefits cost of one full-time dispatcher with an annual 5% increase. Along with 5% of the annual CAD/RMS maintenance costs. Approximately \$153,000 a year.

Earlier discussions brought up the possibility of an RFP process for dispatch services and the County ultimately decided to move forward with a five-year renewal on the West-Comm services agreement.

The recommendation to the Board is to extend the agreement for five more years and continue with the 5% annual escalator. The fiscal year 22-23 budget includes Ranger service revenues. If the 4^{th} amendment is not approved, approximately \$80,000 of budgeted costs would need to be paid by member agencies from January through June 2023. Member agencies annual assessments would also increase between \$156,000 - \$188,000 over the next five years.

Board Member Morales inquired what the original billing plan was in 2007 on the initial agreement. Director Edwards advised that it was based on 200 calls for service a year at \$60,000 a year.

Board Member Morales asked if there were any concerns the County had regarding the agreement. Director Edwards responded that there were not any concerns regarding West-Comm. It was only because it had been 15 years since the last RFP. Although after the County looked into the possibility of switching agencies, it wasn't cost effective due to how integrated they are with West-Comm and their systems.

City Manager Grant commented on the good job City Manager Ingram and Director Edwards did on lobbying the County to help short-circuit the RFP process.

Chairperson Moore commented that he thought the agreement was very reasonable.

With no further questions, Board Member Morales made a motion to approve the fourth amendment for Ranger dispatch services with the County of Orange. Chairperson Moore seconded the motion.
