

RESOLUTION NO. 13-06

A RESOLUTION OF THE WEST CITIES POLICE COMMUNICATIONS CENTER, JOINT POWERS AUTHORITY (WEST-COMM), AMENDING RESOLUTION NO. 08-06 BY UPDATING HOURLY WAGES FOR TEMPORARY PART-TIME EMPLOYEES

WHEREAS, the West Cities Police Communications Center Joint Powers Authority ("West-Comm") comprised of the Cities of Los Alamitos, Cypress and Seal Beach, has been established to provide for the delivery of police communications and dispatch center operations; and

WHEREAS, in 2008, the West-Comm Board of Directors adopted Resolution 08-06, which amended Resolution No. 05-06 to provide for an hourly rate for part-time and temporary employees with the salary range established for the full time employees of the same classification (Dispatcher); and

WHEREAS, the West-Comm Board of Directors now desires to update the compensation schedule for temporary part time employees in the classification of Dispatcher by amending Resolution 08-06; and


WHEREAS, it is further recommended that in the future, the hourly wage for part-time and temporary classification be consistent with that of the full-time classification as reflected within the West Cities Police Employees Association Memorandum of Understanding.

NOW, THEREFORE, THE BOARD OF DIRECTORS OF WEST CITIES POLICE COMMUNICATIONS CENTER JPA DOES HEREBY RESOLVE, ORDER AND DETERMINE THE FOLLOWING:

Resolution No. 08-05 is hereby amended to reflect Exhibit A – "Hourly Pay Ranges" attached hereto.

Temporary Part-Time Dispatchers shall be paid the same hourly pay range as assigned for a regular Full-Time Dispatcher.



Effective: July 19, 2013 (1.5% Increase) :
