# 4. ADOPT WEST-COMM FISCAL YEAR 2020-21 BUDGET

Communications Director Edwards presented to the board the proposed budget for fiscal 2020/21. Communications Director Edwards reported the Dispatch Managers position will remain vacant through 20/21. Communications Director Edwards confirmed there is a salary savings of .7 percent and that does include the CalPers and MOU increase.

Communications Director Edwards reported an increase of 4 percent to Supplies and Services. Communications Director Edwards stated the increase is due to annual maintenance and licensing for the virtual CAD/RMS servers. Communications Director Edwards proposed an increase under Building Maintenance for a deep cleaning to the dispatch center during these unsettling times.

Communications Director Edwards reported IT security awareness has been added to staff development for training and telephone cost continues to obtain a savings. Communications Director Edwards explained the \$3500.00 dollar increase to travel is due to the state increasing their reimbursement for POST required training.

Communications Director Edwards confirmed there is a \$1700.00 dollar increase to liability and this is with no prior claims, Administration will be researching new insurance providers. Ms. Ingram assured the board the AOS will make this a top discussion item.

With no further questions, Board Member Kalmick made a motion to approve and adopt the West-Comm Fiscal 2020-2021 budget which was seconded by Board Member Morales.
